“We’ve made many significant improvements and upgrades to our facilities this year through the use of the permanent improvement funds,” Interim Superintendent Schmidt said. “This includes repaving parking lots and repairing roofs at several elementary schools, retiling the floor at Royal Manor, and upgrading the bathrooms and auditorium at the high school.”

Interim Superintendent Schmidt noted that graduation is just around the corner, and that the Board of Education plans to recommend 530 graduates of the class of 2016. He also mentioned that students still need to continue to perform until the end of the school year since a recommendation does not automatically guarantee graduation.

“We’ve also spent this month welcoming Mr. Barrett,” Interim Superintendent Schmidt said. “He has spent several days touring the district and meeting students and staff. We’re excited for the direction of GJPS under his leadership.”
