PRE-EMPLOYMENT CRIMINAL RECORDS CHECK

Ohio law (House Bill 79 and House Bill 190) mandates a criminal history records check for 'individuals under final consideration for employment in a position involving care, custody or control of a child.' If you are offered a paid or volunteer position with our school district, this will require that you have both a Bureau of Criminal Identification and Investigation (BCI) records check **AND** a Federal Bureau of Investigations (FBI) records check completed at our Office of Human Resources.

Costs for the criminal records checks are: \$25 – BCI, \$26 – FBI, or \$51 – Both. Payment must be made by cash, check or money order. If you've completed a criminal records check through another source within the past year, please inform the Office of Human Resources.

Employment may be denied to any such applicant convicted of a criminal offense, provided that such determination is made on a case-by-case basis, and upon consideration of each of the following factors:

- 1. The nature and gravity of the offense(s)
- 2. The time that has passed since the conviction and/or completion of the sentence
- 3. The nature of the job held or sought

Offences that may be considered grave and job-related shall include, but not be limited to: felonies, offenses of violence, theft offenses, sex offenses, offenses against the public peace, offenses involving drug abuse (including alcohol), or any serious or job-related misdemeanor.
